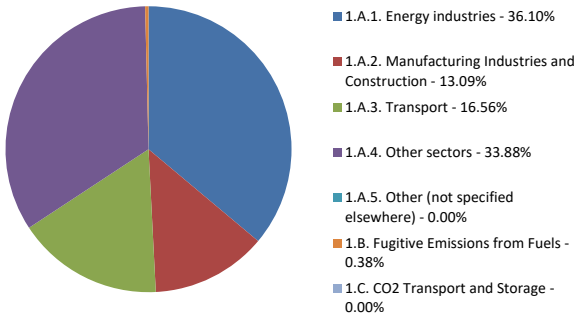




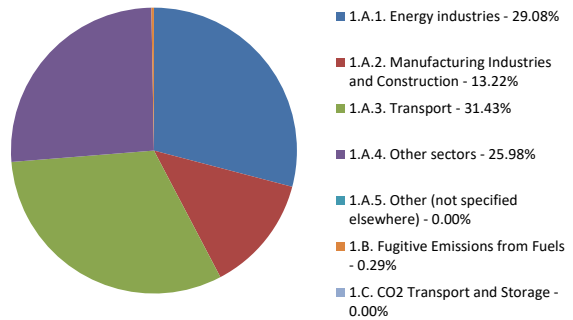


Breakdown of GHG emissions within the energy sector

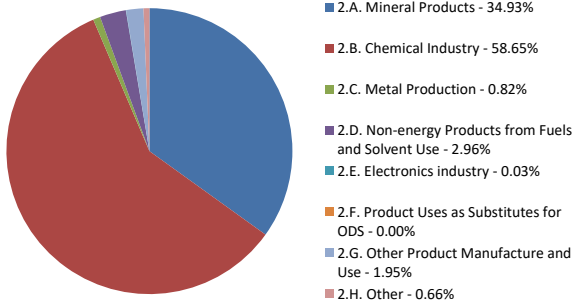

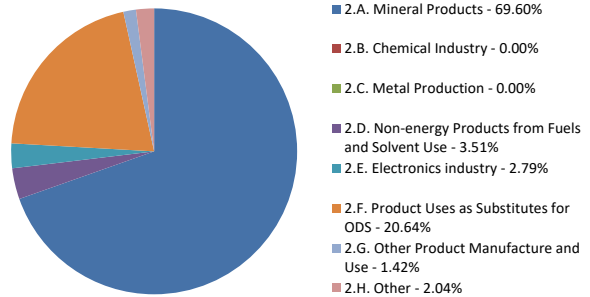


Breakdown of GHG emissions within the industrial processes and product use sector

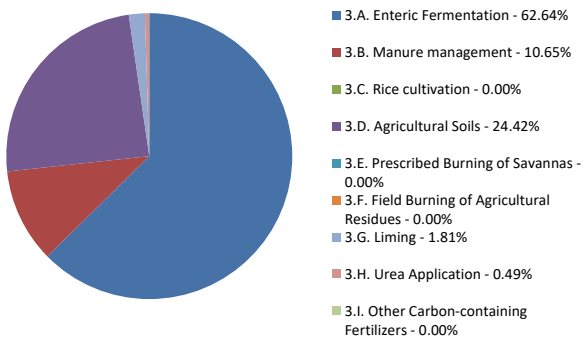

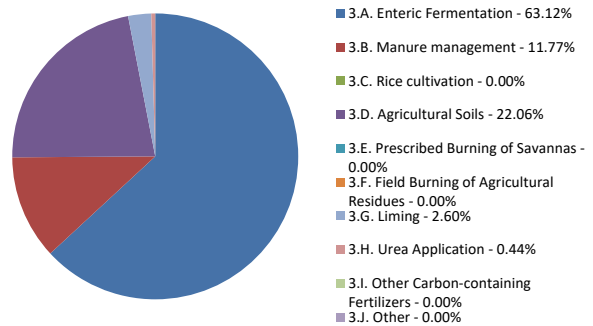


Breakdown of GHG emissions within the agriculture sector

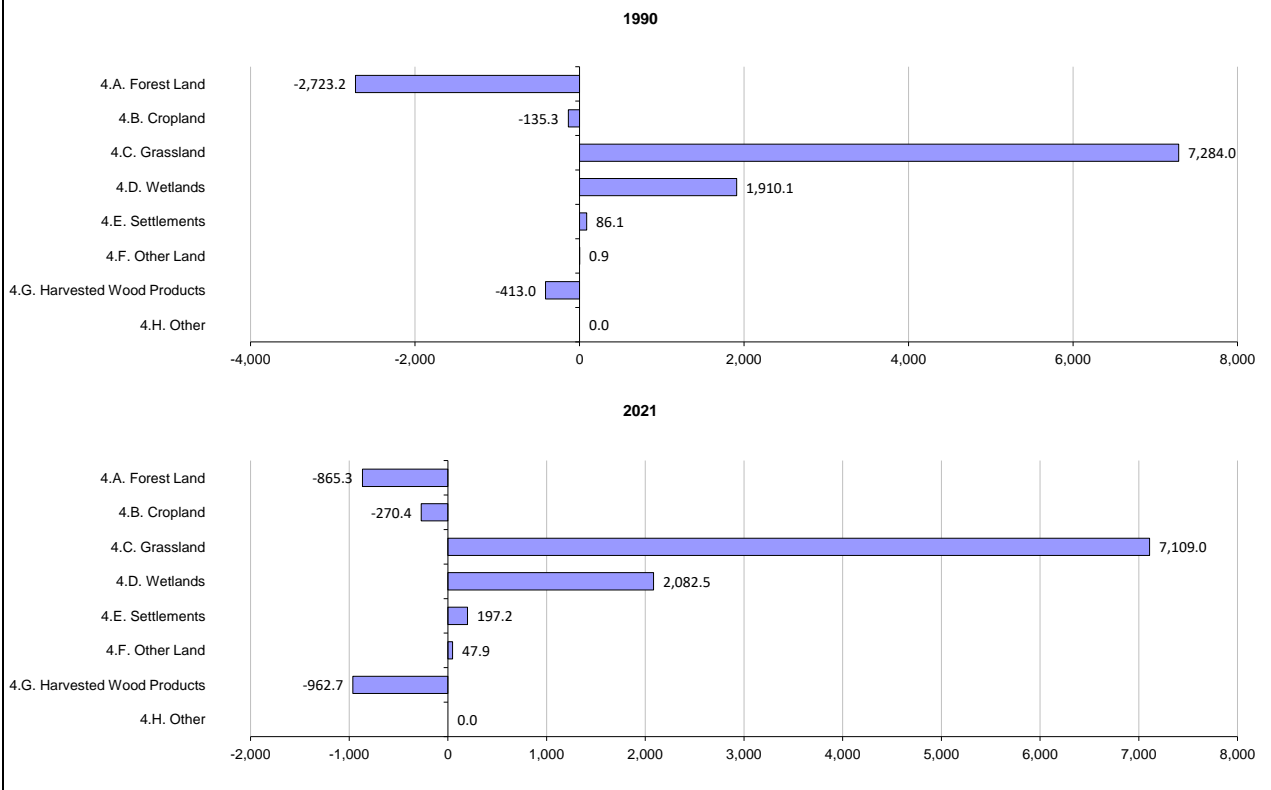
